***Your annual membership benefits include:***

*Voting privileges*

*Third-party liability insurance – provides coverage for a member who owns a standardbred horse which causes bodily injury or property damage. Policy provides \$1,000,000 per occurrence and \$5,000,000 aggregate. Please see following page for additional information.*

*Animal mortality coverage provides limited animal mortality coverage for an eligible dues-paying member-owned standardbred horse while at Running Aces, of up to \$15,000 for a horse which is racing, up to \$5,000 for a horse in training, and up to \$3,000 per horse for tack with a maximum of \$10,000 tack coverage for any one owner.*

*On track accident insurance at Minnesota County Fairs.*

*Limited coverage for damage to race bike which occurs on the track at Running Aces and at licensed Minnesota County Fairs. Payment is determined by age of race bike, and all claims must be approved by the MHRI Board of Directors.*

*MHRI Stall Service Fee Reimbursement Program for members stabled on the backstretch at Running Aces.*

*Representation of member issues before Running Aces track management, the Minnesota Racing Commission and at the Minnesota Legislature.*



## ***MHRI Stall Service Fee Reimbursement Program***

1. Running Aces has increased the monthly *Stall Service Fee* by 20%, from \$100/mo. to \$120/mo.
2. The 2019 *Stall Service Fee* of \$120/mo. applies to each horse stall that trainers have been allocated.
3. Running Aces will charge each trainer the *Stall Service Fee* for the months of May, June, July and August.
4. There will be NO CHARGE for the month of September.
5. The MHRI Board of Directors have decided to continue to reimburse the full amount of the \$120/month *Stall Service Fee* to all trainers billed by Running Aces on the condition that the trainer and ALL of the owners that are listed in the Official Program of the horses he or she trains are members in good standing of MHRI. (Minnesota Harness Racing Inc.)
6. The 2019 MHRI Membership Fee is \$60.
7. Trainers will be billed by Running Aces at the end of each month. Once that bill is paid, trainers may bring their receipt of payment to the MHRI Office, and after it has been determined that all of the horses in the trainer's care are eligible for this reimbursement, through proof of MHRI membership, the Executive Secretary or Treasurer will cut a check payable to the trainer.
8. Membership application forms are available at the MHRI Office. The application form must be completed and membership fees must be paid in full before any request for reimbursement of *Stall Service Fees* is processed.
