## MHRI County Fair Racing Conditions

MHRI races under the rules and regulations of the United States Trotting Association. In addition, the following conditions and policies will govern races at MHRI sponsored meets.

- Entry fees: \$40.00.  
Horses may only enter one race at each fair.
- Proof of negative Coggins test within one (1) year is required at all race meets.
- Per Rule 13, Section 13.05 of the USTA rules: in overnight events, if there are less than five (5) starters, the premium for the positions for which there are no starters may be retained by the Association.
- **MN Owned is defined as a horse of which at least a 50% interest is owned by a MN resident. Residency is defined per MN Department of Revenue status.**
- In the event of a rainout, money may be carried over to the next year at the discretion of MHRI.
- Races may be charted at all MHRI sponsored meets in Minnesota as per majority of horsepersons entered.
- We reserve the right to split according to the entries received and track conditions.
- Maximum number of starters per race:

Cannon Falls - Score 5, Start 8

St. Peter - Score 4, Start 7

Wheaton – Score 5, Start 8

- MHRI provides race day accident insurance for all drivers at MHRI sponsored race meets.



## MHRI County Fair Racing Conditions (Continued)

- All owners, trainers and drivers must have liability insurance which is provided through membership in the MHRI for 2022. Those who are not members will be allowed to join on race day.
- Drug testing on horses can be conducted at all MHRI sponsored meets at any time, pre and post-race. Levels for approved medications will be at the same levels allowed and tested for at Running Aces.
- Breathalyzer testing may be conducted at all MHRI meets. The following individuals may be tested: drivers, anyone warming up a horse, and appointed officials.
- The following point system is used for year-end awards for horses and drivers for the MHRI sponsored race meets:

1 <sup>st</sup> Place	50 Points
2 <sup>nd</sup> Place	25 Points
3 <sup>rd</sup> Place	12 Points
4 <sup>th</sup> Place	08 Points
5 <sup>th</sup> Place	05 Points

## Minnesota Bred Races at Running Aces

There are 8 races scheduled for 2YO pacers, and 8 races for 2YO trotters, which will be conducted on Tuesday/Thursdays beginning on July 12/14, 2022, in addition to the Finals which will be conducted on Minnesota Night of Champions.

There are 12 races scheduled for 3YO pacers, and 12 races for 3YO trotters, which will be conducted on Thursday and Sunday beginning on May 26/29, 2022, respectively, in addition to the Finals which will be conducted on Minnesota Night of Champions.

Each scheduled race for 2YO and 3YO MN Breds will have an estimated total purse of between \$33,000 if more than one division.

2YO & 3YO races may split, if possible, first by sex to create full and balanced fields.

If enough horses are not entered to separate by sex, horses will then be divided by lifetime earnings (2YO's) and earnings in last 4 starts (3YO's) to create full and balanced fields.

If the scheduled race goes ONE division, it will go for the entire purse of \$18,000.

If the scheduled race goes TWO divisions and is split by sex, monies will be added to the base purse of \$18,000 and each division will race for \$16,500.

If the scheduled race goes TWO divisions, split by earnings, monies will be added to the base purse. The A division will race for \$19,800 (60%) and the B division will race for \$13,200 (40%)

If the scheduled race is divided into 3 divisions, split by earnings, monies will be added to the base purse. The A division will race for \$16,500 (50%), the B division for \$9,900 (30%), and the C division \$6,600 (20%).

If the scheduled race is split into 3 divisions monies will be added to the advertised purse with 2 of the divisions of one sex split by earnings and a 3<sup>rd</sup> division of the other sex. The same sex divisions will each race for \$12,375 (37.5%) with the other sex division racing for \$8,250 (25%).



If 2YO races are split by earnings, it will be based on LIFETIME EARNINGS. If 3YO races are split by earnings, it will be based on earnings in their LAST 4 STARTS.

In any case, no uneven fields should be carded and either a division by sex or earnings should be used to create balanced fields if possible. Any other division scenarios will be dealt with by the Race Secretary and after consultation with the MHRI officers.

If a class does not fill with 6 separate betting interests, the race secretary, after consultation with MHRI officers, may card the race as a non-betting race. If there are 3, 4, or 5 separate betting interests, the race will go as a non-betting race. If only 1-2 horses entered, the money will roll over to future MN Bred races.

To have competitive races, horses that win 3 out of the last 4 MN Bred races in the A division (or by sex). that horse will be assigned to the outside post. Winning in the class B & C division then moving to class A, you should not be assigned an outside position. Other scenarios that continue to produce negative betting pools may also be addressed after consultation with the MHRI officers.

If a cancellation of a MN Bred race occurs due to factors beyond our control, for example, technical issues, power outage, weather related, etc., those MN Bred races will be rewritten on the days that the open 2YO and 3YO races were scheduled.

MN Bred horses will receive an extra win in non-restricted, non-winner classes.

MN Bred horses will receive an extra 30% in money earnings in non-restricted conditioned races.

MN Bred horses will receive a 50% allowance in claiming races.

MN Bred horses will receive preference if tied with a horse which is not MN Bred.

MN Bred horses that finish 1-2-3 in a non-restricted race at Running Aces will receive a 30% bonus on those earnings. Purse levels may be adjusted at the discretion of MHRI and Running Aces.



## 2022 Minnesota Night of Champions Conditions

2022 Night of Champions is Saturday, September 17 – First Post at 7 PM.

Fields for the Finals shall be limited to the top nine (9) Money earners of the Final's entrants. For 2 & 3 YO'S it is money that has been earned in MN Bred Restricted races as listed in this booklet.

2YO's must make at LEAST THREE (3) starts, or 50% of their starts, in MN Bred restricted races, as listed in this booklet, to be eligible for the finals at Running Aces. 3YO's must make at LEAST SIX (6) starts, or 50% of their starts, in MN Bred restricted races, as listed in this booklet, to be eligible for the finals at Running Aces. For aged horses, total money earned at Running Aces for the meet will determine eligibility.

If 9 (nine)" Eligible" horses do not enter the Finals (or consolations, if held), Additional Minnesota-Sired Horses that made at least two starts in the state of Minnesota in 2022 shall be drawn into the race. Preference will be given to horses who earned money in the MN-restricted races first, then by total purse money earned in the state of Minnesota. Horses drawn in by these conditions will draw outside regularly qualified horses.

A Finals race must have six separate betting interests at the time of the draw to be considered filled. If an event does not fill, after consultation between the Race Secretary and MHRI officers, the Finals race may be contested as a non-wagering event.

All finals Races must be contested.

All earnings will be calculated from the beginning of the meet up to and including September 11, 2022.

Ties for the final shall be broken by lot.

All Finals shall be contested for the advertised purse.

There shall be no entry or starting fee at the time of entry for the finals. All horses must be eligible to start within current qualifying standards at Running Aces and MRC at the time of entry. Qualifying races shall be held Sunday before the draw for the Night of Champions.
