Treas. Report: Cathy Dessert moved to approve which was 2<sup>nd</sup> by Dan Roland and carried

Lobbyist contract discussion: We talked about renewing our contract with our current lobbyist, Park Street Public.

Dan Roland moved that we renew the contract for 2024 as long as it hasn't changed from last year. Motion was 2<sup>nd</sup> by Jessica Johnson and carried.

Danielle Drollinger discussion: Jessica spoke about the situation that occurred with Danielle and Trent. She & Cathy both thought if we are going to contribute to Danielle's care that we give directly to the caregiver rather than the Go-Fund Me account.

Membership/Banquet committee: We discussed adding an award for Caretaker of the year.
